Terms and Conditions:

By signing below, you agree to the following terms and conditions:

- You agree to supervise and take responsibility for your organization regarding this campaign.
- Order forms and samples are provided free with an order of 36 candles or more. If for any reason the sales is not held, you agree to pay for the forms and samples at the following cost: Forms-\$5.00 ea. Sample \$1.00 ea.
- Payment must be received by **Ôæ à|•Ô° P^æoUdã *• prior to shipment**. Payment can be made in the form of a business/school check, money order or certified bank check made payable **Ôæ à|•Ô° P^æoUdã *•**. No personal checks will be accepted.
- Candles will be delivered within 2 weeks from the date the order is **received**. Failure to follow directions can delay shipment.
- **A minimum order of 36 candles is required to be considered a fundraiser and receive the discounted price with free shipping.**
- All orders must be submitted on master sheets via mail, scanned email or fax. If a seller has failed to fill out a master sheet, the group leader is responsible for filling one out for them. **Ôæ à|•Ô° P^æoUdã *•** will not accept order forms. Any payment notes should be written on a master sheet in the designated area. Be sure all master sheets are clearly readable. Make adjustments if necessary. Any postage costs will be the responsibility of your organization.
- Add-ons will be accepted up to 1 week after the original order is received. Add-ons will be on a separate invoice and will also need to be paid before shipment.
- Delivery will be made by **Ôæ à|•Ô° P^æoUdã *•** or through UPS Ground. A box count will be needed before passing out the orders to the sellers. Sellers will be responsible for checking the orders for accuracy and damage **before leaving the pick up area**. Any problems must be reported to the group leader at that time. **7 UbX'Yg'Vm< YUfhGf]b[g will not be responsible for damages or shortages after the delivery- NO EXCEPTIONS.** If UPS was used to deliver the orders, the group leader will need to call UPS to get a claim number. **Ôæ à|•Ô° P^æoUdã *•** will ship the replacement candles after receiving the claim number and list of damaged candles.
- The order is considered final after delivery. Additional candles less than 36 pieces can be ordered at \$ 1F.00 ea. plus any shipping charges that may apply. **NO EXCEPTIONS.**
